Reporting directly to the Director, Client Services, and as a member of the senior leadership team, you will lead the development and implementation of a risk management and quality improvement culture at PACE. With this goal in mind, you will lead by example and build capacity on an organizational and individual level, developing and communicating PACE's continuous improvement and risk management vision, with a focus on advancing operational efficiencies and effectiveness that support safer quality care and improved client experiences.

Major Responsibilities and Accomplishments:

An important component of your portfolio will involve ensuring the development and maintenance of an Integrated Emergency Management, Risk Management & Business Continuity Plan, as well as leading, supporting and facilitating the development, implementation and management of organization-wide and program/service-specific continuous quality improvement initiatives. Providing leadership for enterprise risk management processes, you will engage PACE senior leaders, staff and clients to inform annual and ongoing risk identification and evaluation, the prioritization and implementation of risk mitigation strategies, and the monitoring of strategy effectiveness.

You will identify appropriate statistical, quantifiable and quality indicators, provide leadership across the organization for all phases of accreditation, and advise on the business implications and compliance status regarding legislation, regulations, guidelines, and standards related to quality, risk management and infection prevention and control. Senior leaders and management will also look to you for support in leading quality improvement and risk management initiatives within their own portfolios.

Key Qualifications:

A creative systems thinker with a commitment to the fields of Risk Management and Continuous Quality Improvement, and an understanding of how associated principles and practices can be used within the organization, you bring five (5) years' progressive management experience in health care and/or community services, and two (2) years in a Quality Improvement, Total Quality Management or equivalent role. This track record of success is underpinned by a post-secondary diploma or degree in a related discipline, plus training and/or certification related to quality methodologies and tools (e.g. process mapping/flow diagrams, root cause analysis, PDSA, etc.). Experience in the accreditation process (i.e. Accreditation Canada, National Quality Institute) is preferred.



Adept at thinking and planning strategically and managing tactically, you have expertly led quality improvement and change initiatives, and are conversant with quality improvement philosophies, principles, tools, methodologies and processes. You are also knowledgeable about quality and risk management programs, including design and implementation processes, and project management practices and processes.
